

## 1727 Will of John Linthorne Sen of Poole, Dorset

**Dated: 7 June 1727**

**Proved: No date**

In the name of God Amen. I **John LINTHORNE** sen of ye Town & County of Poole being of perfect mind and memory, and calling to mind & duly considering ye uncertainty of human life make this my last Will and Testament/ First and principally I commit my Soul into ye hands of My Blessed Maker, trusting in his mercies & ye merits of my Dear Redeemer for ye Redemption of all my sins, my Body I commit to ye earth to be decently buried. As to my Temporall Estate I bequeath & dispose of it in following manner.

Imprimis to my son **Benjamin LINTHORNE** His Heirs, Executors, Admin. or assigns forever the house I now dwell in lying and being in ye High Street in Poole afores/ together wth ye malt house Brewhouse fewel (Fowel?) house garden ground & all other of premises belonging thereto together wth all & singular ye appurtenances. Also I ye plott of garden ground wth the stable or fewell house on ye same, also garden ground adjoining to ye premises afores. wch I Bought of **Roger LINTHORNE**.

Item I give and bequeath unto my sons, **John, Shadrack, Thos & Joseph LINTHORNE** each of them one shilling.

Item I give & bequeath to my sons in law **Nathan. BARTLETT & James BRISTOWE** each one shilling.

Item I give and bequeath to my Daughters **Elizabeth BRISTOWE & Mary BARTLETT** & to my daughters in Law **Mary LINTHORNE & Martha LINTHORNE** each of them one shilling.

The residue and remainder of my Estate Lands Tenems. Hereditaments wth my Goods Chattles, mony plate with all other properties of which kind soever to me appertaining I give & bequeath to my beloved wife **Mary LINTHORNE** ye whole & sole Executrix of this my last will & Testament, and I do hereby utterly revoke, disallow dis--- all former wills by me heretofore in any will left or made, declaring ratifying & confirming this, & no other, to be my last will and testament. In witness whereof I have set my hand & seal this seventh day of June in ye year of our Lord One thousand and seven hundred & twenty Seven;

Signed sealed published & declared by ye within named Testator **John LINTHORNE** senr to be his last will and testament, in presence of us who subscribed Our Names in presence of ye said Testator.
